Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depends on the product or service you have with us. This information can include, but is not limited to:</p> <ul style="list-style-type: none"> ● Social Security number and income; ● Assets and transaction history; ● Personal information; and ● Investment experience and risk tolerance. <p>When you are <i>no longer</i> our client, we continue to share your information as described in this notice.</p>

How?	All financial companies need to share clients’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their clients’ personal information; the reasons Signal Advisors Wealth, LLC chooses to share and whether you can limit this sharing.

To limit our sharing	<p>Please note: You can limit your sharing by sending an email to opt-out@signalwealth.us, providing your name, contact information, and details of your request. Certain states have adopted a requirement for you to approve the sharing of information in advance, otherwise known as an “opt-in” choice. If you live in an “opt-in” state (e.g., California, Massachusetts, Maine, Alaska, North Dakota or Vermont), then Signal Advisors Wealth, LLC will require your consent to share your information with unaffiliated third parties who are not servicing your account. State requirements vary and may change without notice.</p> <p>If you are a new client, we can begin sharing your information from the date we sent this notice. When you are no longer our client, we continue to share your information as described in this notice.</p> <p>However, you can contact us at any time to make changes to your privacy settings.</p>

What we do**How does Signal Advisors Wealth, LLC protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Signal Advisors Wealth, LLC collect my personal information?

We collect your personal information, for example, when your financial advisor provides information about you and your accounts to us.

We also collect your personal information from other companies, such as custodians and third-party vendors.

Why can't I limit all sharing?

Federal law gives you the right to: (1) limit sharing of information about your creditworthiness, (2) limit affiliates from using your information to market to you, and (3) limit sharing information about you for non-affiliates to market to you.

State laws and individual companies may give you additional rights to limit sharing

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account if you make that request in the opt-out email.

Definitions**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

Non-affiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
